The Covid-19 pandemic is still very much in the headlines, but with the clock ticking Brexit is literally just around the corner.

With the current position of the EU and the UK and the UK's statement in June 2020 that they will definitely not be seeking a further extension of the transition period, the UK will exit the EU by the end of 2020. This means that from 1 January 2021 customs borders will re-emerge between the UK and EU countries.

All movements to and from the UK will become subject to customs declarations and possible customs duties. Furthermore, the VAT treatment of supplies may change and various tax and non-tax registrations may be required to continue trading with the UK.

Even though the media addresses key developments relating Brexit and the future relationship between the UK and the EU, little is mentioned about the specifics for movements into and from the UK.
